A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY GEORGE YACOUBIAN ON BEHALF OF THE LIFE ALLIANCE ORGAN RECOVERY AGENCY TO HOST THE "BLUE & GREEN DAY CELEBRATION" EVENT AT DOWNTOWN DORAL PARK LOCATED AT 8395 NW 53 STREET DORAL, FL ON FRIDAY, APRIL 11, 2025, FROM 4:00 P.M. то 9:00 P.M.; PROVIDING FOR PROVIDING **IMPLEMENTATION**; FOR INCORPORATION OF **RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS George Yacoubian (the "Applicant") seeks approval from the City of

Doral to host the "Blue & Green Day Celebration" special event at Downtown Doral Park,

located at 8395 NW 53 Street, Doral; and

WHEREAS the purpose of this event is to raise awareness of the pivotal and

lifesaving role of organ donation and to honor the doners and their families; and

WHEREAS staff recommends that the Mayor and City Council approve the

proposed "Blue & Green Day Celebration" special event permit to be held Friday, April

11, 2025, from 4:00 p.m. to 9:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY

COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The special event permit for the "Blue and Green Celebration Day" is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.

- 2. The Applicant shall be required to have all inspections and approvals prior to the event date.
- 3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with the comments made by the City of Doral Police Department.
- 6. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured four weeks prior to the event date.
- 7. If applicable, the Applicant shall secure a maintenance of traffic (MOT) permit from the City of Doral Public Works Department and/or Miami-Dade County Department of Transportation and Public Works prior to event start date.
- 8. The Applicant shall provide overflow parking arrangements.
- 9. All fees due must be paid within thirty (30) days upon special event approval. Total fees due for Blue and Green Celebration Day special event are \$6,898.02 which represents \$755.00 for Police services; \$365.00 for Planning and Zoning and Technology fees and \$778.02 for Parks fees. The applicant will also submit a \$5,000.00. for a refundable security deposit.

Section 3. Effective Date. This Resolution shall become effective immediately

upon its adoption.
