A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY CICI AVELAR ON BEHALF OF PAR 5 GROUP, TO HOST THE "LIV GOLF INVITATIONAL - MIAMI @ TRUMP NATIONAL DORAL", LOCATED AT 4400 NW 87 AVENUE, DORAL, FL 33178 FROM FRIDAY, APRIL 4, 2025 THROUGH SUNDAY, APRIL 6, 2025 FROM 9:00 AM TO 9:00 PM; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Cici Avelar (the "Applicant") seeks approval from the City of Doral to host the "LIV Golf Invitational- Miami @ Trump National Doral" special event located at 4400 NW 87 Avenue, Doral; and

WHEREAS, the purpose of this event is to modernize and supercharge the game of professional golf through expanded opportunities for both players and fans alike; and

WHEREAS, staff recommends that the Mayor and City Council approve the proposed "LIV Golf Invitational -Miami @ Trump National Doral" special event permit to be held from Friday, April 4, 2025, though Sunday, April 6, 2025, from 9:00 a.m. to 9:00 p.m.

WHEREAS, during the March 12, 2025 City Council Meeting, the Mayor and City Council affirmatively motion and approved the City's sponsorship by assisting with the promotion of the LIV Golf Invitational Miami through the placement of banners on City owned light poles and bus benches.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The special event permit for the "LIV Golf Invitational -Miami

@ Trump National Doral" is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to have all inspections and approvals prior to the event date.
- Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with the comments made by the City of Doral Police Department.
- The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured four weeks prior to the event date.
- 7. If applicable, the Applicant shall secure a maintenance of traffic (MOT) permit from the City of Doral Public Works Department and/or Miami-Dade County Department of Transportation and Public Works prior to event start date.
- 8. The Applicant shall provide overflow parking arrangements.
- 9. All fees due must be paid within thirty (30) days upon special event approval. Total fees due for LIV Golf Invitational Miami @ Trump National Doral special event are \$184,299.60 which represents \$183,934.60 for Police services and \$365.00 for Planning and Zoning Technology.

<u>Section 3. Sponsorship Implementation.</u> The Mayor and City Council hereby approve the City sponsorship of the LIV Golf Invitational, and authorize use of the City logo, authorize the creation of banners that will promote the LIV Golf Invitational event, and allow for the use of City light poles to display the banners, and allow for the temporary use of City owned bus benches for the promotion of the LIV Golf Invitational.

<u>Section 4. Expenditure of Budgeted Funds.</u> The Mayor and City Council hereby authorize the City Manager to expense budgeted funds in order to carry out this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
