## **RESOLUTION No. 25-99**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE THE ATTACHED HOST AGENCY AGREEMENT WITH THE URBAN LEAGUE OF PALM BEACH COUNTY, INC. FOR JOINT ENGAGEMENT IN THE URBAN SENIOR JOBS PROGRAM (USJP); PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, it has been a priority of the City of Doral (the "City") to establish

strategic partnerships with local agencies to enhance City services; and

WHEREAS, becoming a host agency will provide the City with temporary additional manpower to strengthen the programs and services we provide to the community; and

WHEREAS, the program will also provide seniors with an opportunity to gain meaningful work experience and be compensated through USJP for the hours worked per week; and

WHEREAS, staff has recommended that the Mayor and City Council authorize the

City Manager to execute the attached Host Agency Agreement with the Urban League of Palm Beach County, Inc. for four (4) years commencing upon execution.

## NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> That it approves and authorizes the City Manager to execute the attached Host Agency Agreement with the Urban League of Palm Beach County, Inc. for joint engagement in the Urban Senior Jobs Program, together with such

non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

**Section 3.** <u>Authorization</u>. The City Manager is authorized to execute all necessary documents, upon the City Attorney's approval as to form and legal sufficiency, and to expend budgeted funds on behalf of the City in furtherance of this approval.

**Section 4.** Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
