

RESOLUTION No. 26-14

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE ADOPTION OF A NO-THROUGH TRUCKING ORDINANCE ALONG NW 112 AVENUE, BETWEEN NW 25 STREET AND NW 29 STREET, AND NW 27 STREET BETWEEN NW 112 AVENUE AND NW 108 AVENUE; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in 2004, the City of Doral (the “City”) via Resolution 04-101, executed a Road Transfer Agreement with Miami-Dade County; and

WHEREAS, pursuant to the 2004 agreement, Miami-Dade County retains right over traffic engineering, including the opening and closure of roadways; and

WHEREAS, the expansion of industry has led to an increase of heavy commercial truck traffic; and

WHEREAS, the combination of young students traveling along sidewalks that abuts heavy commercial traffic creates a dangerous situation that places the life of Doral’s children in harm’s way; and

WHEREAS, in order to mitigate this risk, the City desires that a no-through trucking ordinance be adopted during specified hours in order to ensure that Doral Academy students are able to travel in and out of the school during drop-off and pick-up times; and

WHEREAS, given that Miami-Dade County has jurisdiction over traffic-engineering, it is necessary that the no-through trucking ordinance be done in coordination with Miami-Dade County’s Public Works Department; and

WHEREAS, the City Mayor and Council find that a temporary no-through trucking Ordinance, restricting heavy commercial trucking traffic during the drop off and pick-up times at Doral Academy are in the City’s best interest; and

WHEREAS, the City Mayor and Council instruct the City Manager to and City Attorney to take all necessary actions to transmit this Resolution to Miami-Dade County, and take all necessary action in order to achieve this Resolution's intent.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Incorporation of Recitals. The aforementioned recitals are incorporated herein by reference.

Section 2. Approval. The City Council approves this resolution and transmission to Miami-Dade County in order to achieve the temporary no-through commercial truck traffic along NW 112 avenue between NW 25 street and NW 29 street, and NW 27 street between NW 112 avenue and NW 108 avenue during the drop-off and pick-up of students a Doral Academy.

Section 3. Implementation. The City Manager and City Attorney are authorized to take all necessary steps to implement this Resolution, including transmission of this Resolution to Miami-Dade County, executing any necessary agreement or document, and the expenditure of budgetary funds necessary to achieve the intent of this Resolution. The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.

The Prime Sponsor of the foregoing resolution is Councilman Rafael Pineyro.

The foregoing Resolution was offered by Councilmember Reinoso who moved its adoption. The motion was seconded by Vice Mayor Cabral and upon being put to a vote, the vote was as follows:
