**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF FISCAL YEAR 2025-2026 COMMUNITY BASED ORGANIZATION FIRST CYCLE GRANTS IN THE AMOUNT OF FIVE THOUSAND EIGHT HUNDRED TEN DOLLARS AND 00/100 (\$5,810.00) TO MIND & MELODY; FIVE THOUSAND SIX HUNDRED DOLLARS AND 00/100 (\$5,600.00) TO SHINE BRIGHT FOUNDATION; FIVE THOUSAND FOUR HUNDRED AND SIXTY DOLLARS AND 00/100 (\$5,460.00) TO VET INFO INC.; FOUR THOUSAND FIVE HUNDRED AND SIXTY DOLLARS AND 00/100 (\$4,560.00) TO MIAMI YOUTH ORCHESTRA; THREE THOUSAND FIVE HUNDRED AND SEVENTY DOLLARS AND 00/100 (\$3,570.00) TO FRIENDS OF DORAL SCOUTS INC.; THREE THOUSAND FIVE HUNDRED DOLLARS AND 00/100 (\$3,500.00) TO EDUCATION FOR ALL, INC; AND THREE THOUSAND FIVE HUNDRED DOLLARS AND 00/100 (\$3,500.00) TO PERLA DE ESPERANZA; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral received fourteen (14) applications by eligible organizations in response to the FY2025 Cycle of Community Based Organization (CBO) Grant Applications by December 3<sup>rd</sup>, 2025; and

**WHEREAS**, after careful review of the applications, the CBO Evaluation Committee respectfully recommends that the Mayor and City Council approve CBO awards to each of the following organizations:

1. Friends of Doral Scouts Inc. - \$3,570.00
2. Miami Youth Orchestra - \$4,560.00
3. Mind & Melody - \$5,810.00
4. Shine Bright Foundation - \$5,600.00
5. Vet Info Inc. - \$5,460.00
6. Education for All - \$3,500.00

7. Perla de Esperanza - \$3,500

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

**Section 2. Approval.** The Mayor and the City Council of the City of Doral hereby approve a CBO award of Three Thousand, Five Hundred Seventy Dollars and 00/100 (\$3,570.00), to Friends of Doral Scouts Inc.; Four Thousand, Five Hundred and Sixty Dollars and 00/100 (\$4,560.00), to Miami Youth Orchestra; Five Thousand Eight Hundred Ten Dollars and 00/100 (\$5,810.00), to Mind & Melody; Five Thousand, Six Hundred Dollars and 00/100 (\$5,600.00), to Shine Bright Foundation; Five Thousand, Four Hundred Sixty Dollars and 00/100 (\$5,460.00), to Vet Info Inc; Three Thousand Five Hundred Dollars and 00/100 (\$3,500.00), to Education for All Inc; and Three Thousand Five Hundred Dollars and 00/100 (\$3,500.00), to Perla de Esperanza. The City Manager is authorized to disburse budgeted funds in order to effectuate this Resolution.

**Section 3. Authorization.** The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent with the Council's intent.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its adoption.
