

RESOLUTION No. 26-175

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO ACCEPT A DONATION FROM S1 SECURITY GROUP OF TWO (2) POLICE CANINES, WITH A COMBINED VALUE OF THIRTY EIGHT THOUSAND DOLLARS AND 00/100 (\$38,000.00), FOR USE BY THE CITY OF DORAL POLICE DEPARTMENT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AUTHORITY TO ACCEPT THE DONATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, police canines are an invaluable resource for law enforcement agencies and significantly enhance officer capabilities, operational effectiveness, and community safety; and

WHEREAS, by letter dated August 28, 2026, S1 Security Group, through its President & CEO, Rolando E. Palma, notified the City of Doral's (the "City") Police Chief of its offer to donate two (2) police canines to the City of Doral Police Department, consisting of one (1) dual-purpose police canine trained to perform multiple law enforcement functions and one (1) single-purpose police canine trained to perform a specialized law enforcement function, with a combined value of Thirty Eight Thousand Dollars and 00/100 (\$38,000.00); and

WHEREAS, the donation will assist the Doral Police Department in expanding and strengthening its Canine Unit and will provide the Department with additional resources in support of its mission to protect and serve the community; and

WHEREAS, the City's Mayor and Council desire to accept this generous donation on behalf of the City and to express its appreciation to S1 Security Group for its support of the Doral Police Department; and

WHEREAS, the City's Mayor and Council find that the acceptance of this donation serves a valid municipal and public purpose and is in the best interest of the health, safety, and welfare of the City's residents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Incorporation of Recitals. The foregoing recitals are true and correct and are hereby incorporated into this Resolution by reference as findings of fact of the City Council of the City of Doral.

Section 2. Authority to Accept Donation. The City Council hereby authorizes the City Manager, or designee, to accept, on behalf of the City of Doral, the donation from S1 Security Group of two (2) police canines — one (1) dual-purpose police canine and one (1) single-purpose police canine — with a combined value of Thirty Eight Thousand Dollars and 00/100 (\$38,000.00), for use by the City of Doral Police Department, as provided in the enclosed donation letter.

Section 3. Implementation. The City Manager, or designee, is hereby authorized to take any and all actions and to execute any documents, acknowledgments, letters of appreciation, or agreements necessary or convenient to accept, implement, and effectuate the donation described herein, including the assignment, training, deployment, and care of the donated police canines within the Doral Police Department's Canine Unit, consistent with applicable City policies and procedures.

Section 4. Effective Date. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilmember Reinoso who moved its adoption. The motion was seconded by Councilmember Pineyro and upon being put to a vote, the vote was as follows:
