

RESOLUTION No. 26-60

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING WORLD SOCCER EVENT, LLC TO SEEK ADMINISTRATIVE APPROVAL FOR SPECIAL EVENT PERMITS FOR THE “DORAL CUP” SUBJECT TO LIMITATIONS AND CONDITIONS; AUTHORIZING THE USE OF THE CITY LOGO; PROVIDING FOR A TERM; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, World Soccer Event, LLC, (“Event Organizer”) has a history of organizing a successful youth soccer tournament annually within the City of Doral (the “City”) pursuant to City Council approved special event permits (the “Doral Cup”); and

WHEREAS, the Doral Cup seeks to highlight local talent, strengthen community pride, and position the City as a key hub for youth sports development; and

WHEREAS, the Doral Cup re-affirms the City’s initiative and commitment to establish the City as a sport enthused City while offering residents and visitors a safe environment to enjoy said activities; and

WHEREAS, Article II of Chapter 35 of the City’s Code of Ordinances, titled “City of Doral Special Events Ordinance,” (the “Ordinance”) requires that organizers who seek to have a special event within the City to first obtain a special event permit; and

WHEREAS, Section 35-20 of the Ordinance further provides that events that expect 400 or more attendees shall require the approval of the City Council; and

WHEREAS, the City Council desires to streamline and expedite the process by which Event Organizer can host Doral Cup in the City by authorizing the Event Organizer to obtain special event permits for Doral Cup through an administrative review and approval process, without the need of City Council approval at a public hearing, notwithstanding that said events will expect more than 400 attendees, subject to the

limitations set forth herein; and

WHEREAS, the City Council finds that the adoption of this resolution will promote the public's health and welfare by providing safe and quality running/race events to the City's residents and visitors.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Authorization: Limitations. The City Council hereby authorizes World Soccer Event, LLC to seek administrative approval for the Doral Cup special event permits, even where the events anticipate 400 or more attendees, without the need to seek additional City Council approval, subject to the following limitations and conditions:

1. The special event authorized for administrative approval pursuant to this Resolution shall be limited solely to the annual Doral Cup tournament.
2. Any special events sought to be hosted by World Soccer Event, LLC beyond the annual Doral Cup as provided for herein shall require City Council approval.
3. In accordance with the procedures set forth in Chapter 35 of the City's Code of Ordinances, World Soccer Event, LLC shall apply for, and obtain, a special event permit issued by the City's planning and zoning department for the Doral Cup sought to be hosted by World Soccer Event, LLC pursuant to this Resolution.
4. World Soccer Event, LLC shall be permitted to utilize the City logo solely for marketing and advertising materials related to the Doral Cup tournament only. Notwithstanding the foregoing, all material/use of the City logo shall be first approved by the City's Public Affairs department.
5. World Soccer Event, LLC shall still be required to pay all fees and costs imposed by the City related to the special events, including but not limited to

application fees and any other costs incurred by the City in providing services to support the event.

World Soccer Event, LLC shall secure all necessary and required building, electrical, plumbing, Maintenance of Traffic (MOT), or other municipal or Miami-Dade permits, separate from the special event permit, as may be required prior to issuance of a special event permit. Except as otherwise stated and specifically provided for herein, World Soccer Event, LLC shall comply with all requirements of Chapter 35 of the City's Code of Ordinances related to special events.

Section 3. Term; Revocation. The authorization provided for in Section 2 of this Resolution shall be effective for a term of three (3) years, unless extended or otherwise amended, by action of the City Council. The City Council, may, at its sole discretion revoke the authorization provided for in Section 2 of this Resolution before the expiration of the three (3) year term with or without cause.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Reinoso who moved its adoption. The motion was seconded by Councilmember Pineyro and upon being put to a vote, the vote was as follows:


