

**RESOLUTION No. 26-79**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ACCEPT THE QUOTE SUBMITTED BY FLORIDA CDI LLC DBA CHRISTMAS DESIGNERS IN AN AMOUNT NOT TO EXCEED ONE HUNDRED ELEVEN THOUSAND SEVEN HUNDRED FIFTY TWO DOLLARS AND 00/100 (\$111,752.00), TO PURCHASE A NEW 40-FOOT LED HOLIDAY TREE WITH A 6-FOOT TREE TOPPER AND NEW ORNAMENT PACKAGE; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral's (the "City") Parks & Recreation Department respectfully seeks approval and authorization from the Mayor and City Councilmembers to authorize the City Manager to accept the quote received by Florida CDI LLC dba Christmas Designers to purchase a new holiday tree to be displayed outside of Doral Government Center; and

**WHEREAS**, the existing tree will be moved and displayed at Doral Central Park in lieu of renting a tree; and

**WHEREAS**, throughout the years, the Downtown Doral area has continued to develop and grow, especially with the addition of the UHealth building, the new Library and additional developments; and

**WHEREAS**, the Park & Tree lighting event has also continued to grow in attendance, and a larger tree is now needed to match the growth and stature of the surrounding area; and

**WHEREAS**, the recommended holiday tree is a 40-foot Majestic Branch Tree equipped with 38,150 warm white LED bulbs, a 6-foot tree topper and ornaments; and

**WHEREAS**, the City has an existing agreement with Florida CDI LLC dba Christmas Designers for the holiday lighting and installation/break down of the Holiday Tree; and

**WHEREAS**, it is in the City's best interest to purchase the new tree from Florida CDI LLC dba Christmas Designers; and

**WHEREAS**, the department has funding available for the purchase allocated under the Parks & Recreation Account- Park Impact Fee Fund 102.90005.500640 (Capital Outlay-Office).

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval & Authorization.** The Mayor and City Council hereby approve accept the quote received by Florida CDI LLC dba Christmas Designers to purchase a new holiday tree to be displayed outside of Doral Government Center, in an amount not to exceed One Hundred Eleven Thousand, Seven Hundred Fifty-Two Dollars and 00/100 (\$111,752.00). Funding is available in Parks & Recreation Account- Park Impact Fee Fund 102.90005.500640 (Capital Outlay-Office).


