

**RESOLUTION No. 26-97**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ACCESS TIPS CONTRACT No. 220105 PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, FOR THE PURCHASE OF FOUR (4) FIREWALL HARDWARE UNITS, LICENSE AND SUPPORT; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Information Technology Department respectfully requests approval to purchase four (4) firewall hardware units, licensing, and support to replace aging equipment, resolve performance bottlenecks, and provide future-proof architecture to meet our growing demands; and

**WHEREAS**, the purchase of four (4) new firewalls to replace current equipment will deliver significantly higher processing power, with multi-gigabit speeds capable of handling modern, high-bandwidth security inspections; and

**WHEREAS**, a well-maintained firewall protects our digital assets, reducing the risk of data breaches, downtime, and financial losses from cyberattacks. Modern enterprise firewalls feature dramatically higher maximum concurrent sessions and security rules to accommodate proliferating IoT and user devices; and

**WHEREAS**, it's important to note that Section 119.0725(b) of the Florida Statutes creates a public records exemption related to cybersecurity. Specifically, the statute makes confidential and exempt from public record requirements any information related to critical infrastructure. Additionally, any portion of a meeting that might reveal such information is also exempt from public meeting requirements. See Section 119.0725(3), Florida Statutes; and

**WHEREAS**, Section 2-322 of the City's Code of Ordinances, provides that the Council may enter into contracts procured by other public entities and cooperative purchasing ventures. Accordingly, the City may solicit the goods and services provided by vendors participating in the mentioned contracts which were competitively procured; and

**WHEREAS**, the City Manager respectfully requests that City Council approve the purchase of four (4) firewall hardware units, licensing, and support to replace aging equipment, accessing TIPS contract No. 220105 through Clarium Managed Services, for an amount not to exceed budget funds.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference

**Section 2. Approval.** The purchase of four (4) firewall hardware units, licensing, and support to replace aging equipment.

**Section 3. Authorization.** The City Council hereby approves the purchase of four (4) firewall hardware units, licensing, and support to replace aging equipment, accessing TIPS contract No. 220105 through Clarium Managed Services, for an amount not to exceed budget funds.

**Section 4. Implementation.** The City Manager and City Attorney are authorized to take any additional actions necessary to implement this Resolution, including making any modifications, executing any documents and addendums as necessary to effectuate this Resolution, provided that such actions remain consistent

with the Council's intent.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.


