


The purpose of this Letter to Council (LTC) is to provide the Mayor and City Councilmembers information on the planned roadway closure of NW 97<sup>th</sup> Avenue from NW 58<sup>th</sup> Street to NW 66<sup>th</sup> Street. Miami-Dade County (MDC) is proceeding with their planned roadway closure of NW 97<sup>th</sup> Avenue from NW 58<sup>th</sup> Street to NW 66<sup>th</sup> Street starting Monday, January 23, 2023. The closure will last for 3 weeks (weather permitting). Please know that this closure was originally programmed to commence on Monday, January 9, 2023. However, at the request of the City, the start was asked to be pushed back to Monday, January 23, 2023 as to not coincide with the return of school start date and provide time for traffic patterns to normalize after the holidays. Attached please find a copy of the approved Maintance of Traffic (MOT) plan.


This road closure is part of the roadway improvements to NW 97 Avenue from NW 58 Street to NW 70 Street (MDC Project No. 20200117). The work consists of widening the existing roadway from a (2) lane to four (4) lane divided roadway, sidewalks, curb and gutter, bicycle facilities, continuous storm drainage system, signalization, pavement markings and signing, and street lighting.

## LET 399-02 MDC 2020-0017 NW 97 AVE full Closure from NW 58 ST to NW 66 ST (REVISED)

With respect to the above referenced Project, HCI is respectfully requesting approval to implement a complete road closure on NW 97 Avenue from NW 58 Street to NW 66 Street to expeditiously bring the existing grade to match the new roadway proposed grade. This will include the expedited construction of side street connectors, business turnouts and property harmonization's. A comprehensive detour plan will be implemented including static & variable message signage instructing motorists to access local business on the west side of NW 97<sup>th</sup> Avenue through NW 99<sup>th</sup> Avenue which is a parallel adjacent corridor for which these businesses have access to.

Horizon Contractors, Inc. in connection with Miami Dade County will engage in a public information campaign to ensure all local businesses and stake holders are well informed of the proposed timelines, alternate routes and work to be performed during this closure.

This construction work has been intentionally scheduled for after the busy holiday season to minimize impacts. At this time the full 24-hour road closure is scheduled to commence on Monday, January 09, 2023 with a tentative opening scheduled for Monday, January 30, 2023.

A full closure is imperative to perform a safe and expeditious traffic switch while maintain access to local stakeholders and ensuring the safety of the traveling public.
