SEC Rule 15(c)2-12 Continuing Disclosure consists of valuable information about municipal bonds that arises after the initial issuance. This information reflects the financial health or operating condition of the local government as it changes over time, or the occurrence of specific events that can have an impact on key features of the bonds. Types of Continuing Disclosures include annual financial information as well as audited financial statements. Continuing Disclosures are publicly available on the Electronic Municipal Market Access (EMMA) website, operated by The Municipal Securities Rulemaking Board (MSRB).
