I, (we) understand that a Special Inspector inspection log for each building must be displayed in a convenient location on the site for reference by the City of Doral Building Department Inspector. All mandatory inspections, as required by the Florida Building Code, must be performed by the City. The City building inspections must be called for on all mandatory inspections. *Inspections performed by the Special Inspector hired by the Owner are in addition to the mandatory inspections performed by the Department.* Further, upon completion of the work under each Building Permit, I will submit to the Building Inspector at the time of final inspection, the completed inspection log form and a sealed statement indicating that, to the best of my knowledge, belief and professional judgment those portions of the project outlined above meet the intent of the Florida Building Code and are in substantial compliance with the approved plans.
