CHILDREN UNDER 12 YEARS OF AGE MUST BE ACCOMPANIED BY AN ADULT.

THE USE OF THE DIVING BOARDS AND BLOCKS ARE STRICTLY PROHIBITED.

NO BREATHHOLDING EXCERSISES.

COACHING OF ANY KIND, WHETHER IN OR OUT OFTHE WATER, IS NOT PERMITTED.

TO ENSURE PROPER SUPERVISION AND SAFETY, CITY OF DORAL RESERVES THE RIGHT TO LIMIT THE NUMBER OF INDIVIDUALS IN A POOL AND/OR CLOSE AREAS OF THE POOL.

SWIMMING UNDER THE BULKHEAD IS STRICTLY PROHIBITED.

NO RUNNING OR HORSEPLAY.

NO BALLS, TUBES, FLOATS, FINS, DIVING MASKS, OR WATER GUNS ALLOWED.

ALCOHOL, SMOKING AND THE USE OF ELECTRONIC CIGARETTES, VAPES, OR ANY SIMILAR DEVICES ARE STRICTLY PROHIBITED.

NO GLASS OR ANIMALS IN THE FENCED POOL AREA (OR 50 FEET (15240 mm) FROM UNFENCED POOL).

NO FOOD OR BEVERAGES IN THE POOL. NO COOLERS.

PROPER SWIM ATTIRE IS REQUIRED (NO VISIBLE UNDERGARMENTS).

DIAPER DEPENDENT GUESTS MUST WEAR WATERPROOF GARMENTS IN ALL POOLS AND ON ALL ATTRACTIONS.

DO NOT ENTER THE POOL IF SUFFERING A CONTAGIOUS ILLNESS, SKIN LESIONS, OR IF YOU HAVE HAD DIARRHEA IN THE LAST 14 DAYS.

ONLY COAST GUARD APPROVED LIFE JACKETS ARE PERMITTED; NO OTHER FLOTATION DEVICES ARE ALLOWED.

THE CITY IS NOT RESPONSIBLE FOR LOST OR STOLEN ITEMS

REFUNDS

NO REFUNDS OR EXCHANGES; TICKETS WILL NOT BE REPLACED IF LOST, STOLEN, OR UNUSED.

IN THE EVENT OF SEVERE WEATHER OR LIGHTNING, ALL GUESTS WILL BE REQUIRED TO LEAVE THE FACILITY. IF THE FACILITY CLOSES DUE TO WEATHER, RECEIPTS MUSTBE KEPT AND CAN BE USED FOR ANOTHER DAY.

MANAGEMENT RESERVES THE RIGHT TO CLOSE THE FACILITY FOR THE SAFETY OF PATRONS.
