In addition, Proposers are to deliver **two (2) CDs** containing a PDF copy of all materials submitted in the bid. Submittals must include statements of qualifications and experience and other pertinent information for consideration, as indicated in this Request for Proposals. Any submittals received after the due date and time specified, will not be considered.

The City of Doral reserves the right to accept any bid deemed to be in the best interest of the City or to waive any informality in any submittal. The city may reject any or all bids and re-advertise.
