1. Could you please tell me if there is an estimated cost or budget for the above project?
  - Currently the encumbered funds are between \$1 - \$1.5 million. Will be distributed based on the project(s) or the amount of work is needed. Each Fiscal Year will vary on funds available.
2. Are there set dates in which work might begin or when it must be completed by?
  - Will begin once a project is identified. When the City goes out for A Spot Market Quote, an estimated deadline or project completion will be determined.

  - Vendors that are pre-qualified will be invited to participate in spot market competitions and at that time a walk through will be held.
