Below are questions/ clarifications that were received regarding this project as well as the City's responses. This Addendum is and does become a part of the above-mentioned solicitation. This addendum is issued to modify the subject solicitation as follows:

**Revised Deadline for Submittals and Bid Opening: June 2<sup>nd</sup>, 2022, at 11:00 A.M.**  
**Revised schedule is below**

1. No quantities are provided, will the City of Doral be providing quantities?
  - DO NOT SUBMIT PRICING. This is an RFQ and so the items identified was done to give firms an idea of the type of work that will be included in each spot market quote.
    - **Section 2.23 – SPOT MARKET QUOTES** – Vendors that are pre-qualified will be invited to participate in spot market competitions, as needed. The spot market competitions will be in the form of an Invitation to Quote (ITQ) or Work Order Proposal Request (WOPR) that will include the specific goods and/or services required, and may include provisions, as applicable.
2. Based on the Bid Docs we need to have one of the following licenses:  
Certification as an Underground Utility and Excavation Contractor Provided by the State of Florida – OR -  
Certificate of Competency from Miami-Dade County's Construction Trades Qualifying Board.

We have a Certificate of Competency from Palm Beach County, and we have our GC State Contractor license, would this work to be able to submit our Bid?

- Licensing requirements are as per Section 2.2, subsection 2.2.2.1:
    - Certification as an **Underground Utility and Excavation Contractor** Provided by the State of Florida **OR** Certificate of Competency from the County's Construction Trades Qualifying Board as a **Specialty Engineering Contractor**, commensurate to the requirements of the Scope of Work as a **Pipeline Engineering Contractor**.
3. Is the "RFQ Reference Survey" to be sent by us or by the City to the entity providing the reference for completion?
    - Please refer to Section 3.9 REFERENCES:
      - As part of the RFQ evaluation process, the city may conduct an investigation of references including a record check of consumer affairs complaints. Proposer's submission of an RFQ constitutes acknowledgment of the process and consent to investigate. City is the sole judge in determining Proposer's qualifications. **Proposers are responsible for forwarding the Solicitation Reference Surveys to selected references. Forms must be completed and returned to [procurement@cityofdoral.com](mailto:procurement@cityofdoral.com).**
  4. How many surveys are required?
    - Please refer to Section 2.2.3:
      - Proposer must have performed work in the State of Florida on **at least three (3) similar projects of at least \$500,000**. Supporting references must include company name or governmental agency, contact person telephone number and email address. It is the responsibility of the Provider to ascertain that the contact person will be responsive.
