<u>NOTICE</u>: Pursuant to Article V of the City's Code of Ordinance, the City of Doral (the "City") hereby gives notice of its intent to seek sealed bids from interested parties in response to this Invitation to Bid for "ITB No. 2022-25 Floating Debris Removal Services" (the "ITB") to provide the services described herein. Proposals must be received by 10:00 a.m. on Friday, September 30th, 2022.

All submittals shall be publicly opened and recorded by 10:00 a.m., Friday, September 30th, 2022. Late submittals shall <u>not</u> be accepted or considered. Proposals must be submitted electronically through DemandStar or Vendor Registry by the date and time stated above. Any proposals received after the due date and time specified, will not be considered. See attached instructions for further details on E-Bidding.

The City of Doral reserves the right to accept any bid deemed to be in the best interest of the City or to waive any informality in any submittal. The City may reject any or all bids and re-advertise.

PROJECT OVERVIEW

The City is soliciting bids from interested parties for the provision of floating debris removal services on City canals, including operations and management, removal of legal disposal of floating debris such as, without limitation, trees, limbs, branches, logs, mowed grass, trash bags, plastic cups, foam containers, tennis balls, coconuts, mattresses, construction & demolition debris, white debris (fridge, washer, dryer, air conditioner, etc.), storage drums, dead animals, and other similar debris deposited by the act of men or nature in designated canal waterways, by a licensed contractor
