

City Of Doral Request for Qualifications Design Services - Downtown Doral Arts District RFQ No. 2023-07

NOTICE: Pursuant to the Procurement Ordinance, the City of Doral (the "City") hereby gives notice of its intent to use the Statement of Qualifications (SOQs) submitted in response to this RFQ to rank the Consultants according to the most qualified and to then initiate contract negotiations with the top ranked firm. The qualifications and selection of the firm shall be in accordance with F.S.§287.055, Florida Statutes.

All submittals shall be publicly opened and recorded on **10:00 a.m.**, **Friday**, **August 11**, **2023**. Late submittals shall not be accepted or considered. Proposals must be submitted electronically through https://network.demandstar.com/ or Vendor Registry https://vendorregistry.com/ by the date and time stated above. Any proposals received after the due date and time specified, will not be considered.

A non-mandatory pre-proposal conference will be held on Monday, July 24, at 10:00 a.m. via GoToMeeting Conference Call. During this conference all work will be discussed. The Purchasing Division will respond to all questions submitted during the pre-proposal conference by issuance of a written addendum to the RFQ. Attendance to the pre-proposal conference is encouraged.

The City of Doral reserves the right to accept any proposal deemed to be in the best interest of the City or to waive any informality in any submittal. The city may reject any or all proposals and re-advertise.

PROJECT OVERVIEW

The City of Doral ("City") invites experienced, and licensed and qualified individuals or firms to submit statements of qualification (SOQ) in response to this Request for Qualifications (RFQ) for the provision of professional design services of the Downtown Doral Arts District.

The Downtown Doral Arts District will be the City of Doral's blueprint to creating safe, convenient, and sustainable transportation options that meet the needs of the community and increases accessibility. The proposed roadway and infrastructures improvements shall include pedestrian connectivity, connectivity with the City's bicycle network, on-street parking, lighting, landscaping, signing and pavement markings, signage, traffic calming improvements, stormwater improvements, harmonization with adjacent properties, traffic and transit analysis, and NW 84th Avenue shall include a Bus/Trolley route/lane.
