

## City of Doral Invitation to Negotiate (ITN) ITN-2025-12 City Facilities Custodial Services

## **PUBLIC NOTICE – ITN Bid Status**

The City of Doral issued Invitation to Negotiate (ITN) 2025-12 – City Facilities Custodial Services on June 11, 2025. On June 25, 2025 the City's Procurement Department held a Pre-Bid/Proposal Conference at the City Hall. Questions form prospective proposers were addressed as well as site visits to each of the city's facilities that will be serviced under the ITN.

On July 24, 2025 the city received 18 ITN bid responses via Demandstar. Upon the Procurement Department's due diligence, six (6) of the eighteen (18) proposals received were deemed non-responsive to the requirements of the ITN.

On Monday, August 18, 2925, the Evaluation Committee convened in a public Evaluation Committee meeting to review, discuss and rank the 12 responsive proposers which include the following listed in alphabetical order:

Upon conclusion of the meeting, all twelve proposers were ranked and the Evaluation Committee unanimously selected to invite the top five (5) ranked proposers to Phase II of the ITN procurement process; Presentations and Q&A Sessions.

The top five (5) ranked shortlisted proposers pursuant to Phase 1 ranking include:
