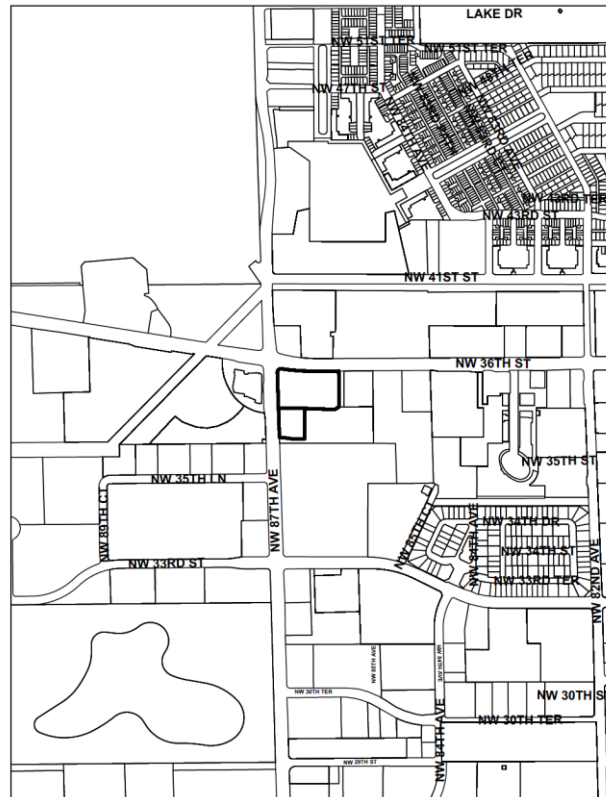
**APPLICANT:** Doral Court Retail Investments, LLC (the "Applicant")
